Email submittals must be received from both shippers so the email addresses can be used as confirmation.

Transport trades cannot increase an imbalance. Trades and transfers cannot cause storage balances to go over MSV or below zero.

Trades and transfers cannot be conducted outside shipper's contracted rights without incurring additional charges pursuant to TIGT's FERC Gas Tariff.

Trades will be recorded in the relevant flow month and will be charged accordingly. Please use a separate trade form for each production month request.

Trade Forms must be submitted in accordance with the time lines provided for in TIGT's currently effective FERC Gas Tariff.

The Preliminary Cashout Schedule, included with the invoice, details the transportation imbalances by month.
