#### **Statement of Nature, Reasons, and Basis for the Proposed Changes**

In Order No. 587-AA, the Commission incorporated into its regulations the most recent version of the NAESB WGQ Standards, Version 4.0, and required natural gas pipelines to: (1) make compliance filings reflecting

the changed standards with the Commission by February 3, 2025; and (2) comply with the new standards on and after August 1, 2025.<sup>3</sup>
