**Statement of Nature, Reasons, and Basis for the Proposed Changes**

On February 3, 2025 In Docket No. RP25-524-000 ("February 3 Filing"), East Cheyenne submitted a filing to comply with Order No. 587-AA, wherein the Commission incorporated into its regulations the most recent version of the NAESB WGQ Standards, Version 4.0, and required natural gas pipelines to: (1) make

compliance filings reflecting the changed standards with the Commission by February 3, 2025; and (2) comply with the new standards on and after August 1, 2025.<sup>3</sup>

Subsequent to the February 3 Filing, East Cheyenne was made aware that two required changes as the result of Order No. 587-AA were not incorporated into the revised tariff record that was submitted with an effective date of August 1, 2025.

The instant filing is being made to incorporate those changes. Specifically, East Cheyenne proposes to:

- Add language referring to the Minor Correction MC24002 in the opening paragraph of the Amended Proposed Tariff Section; and
- Insert an asterisk (\*) next to Dataset 3.4.1 related to Minor Correction MC24002.

### **Waivers and Other Motions**

East Cheyenne respectfully requests that the Commission grant any waivers which may be deemed necessary to accept this filing. As required by Section 154(a)(9) of the Commission's regulations, East Cheyenne hereby moves to place the Amended Proposed Tariff Section into effect as requested herein upon acceptance by the Commission in this proceeding.
