Pursuant to the Operational Purchases and Sales of Gas provisions in Section 35 of the General Terms and Conditions ("GT&C") of East Cheyenne Gas Storage, LLC's ("ECGS") FERC Gas Tariff, First Revised Volume No. 1 ("Tariff") and Section 154.502(c) of the regulations of the Federal Energy Regulatory Commission ("Commission"),<sup>1</sup> ECGS hereby submits for filing its annual report of operational gas purchases and sales transactions for the calendar year ending December 31, 2024 ("Report"). ECGS is filing this Report pursuant to the Commission's eFiling procedures.

#### Background

Pursuant to GT&C Section 35.4 of the Tariff, ECGS must submit an annual report that provides details regarding all operational gas purchases and sales made during the previous calendar year. The Tariff requires ECGS to include in this report: (1) the source of the operational gas purchased or sold; (2) the date of such purchase or sale; (3) the volume purchased or sold; (4) the purchase or sale price; (5) the costs and revenues from such purchase or sale; (6) the disposition of the associated costs and revenues; and (7) an explanation of the purpose of any operational transaction.
