Deliveries to NGL and to Seaway will be assessed additional pump over fees amounting to [U] \$0.08 per barrel for deliveries to NGL and [U] \$0.10 per barrel for deliveries to Seaway.

(2) All movements to the Augusta Destination or the McPherson Destination shall be subject to an additional fee (i.e., in addition to all other applicable tariff rates, fees, and charges) of [U] \$0.10 per barrel.
