Notice of Temporary Embargo: Effective February 29, 2024, a temporary embargo is in place for all movements of PXL Grade Petroleum to the following destinations: the Augusta Destination, located near El Dorado, Kansas; the McPherson Destination located near McPherson, Kansas; the Phillips 66 refinery, located near Ponca City, Oklahoma; and the various Destinations located near Cushing, Oklahoma. The temporary embargo is required due to tank maintenance at the Sterling Terminal and will remain in effect until cancelled by a subsequent tariff filing. The embargoed movements are denoted by the symbol [E].

[F1] This tariff contains rates that are higher for shorter than longer distances over the same route. Such departure from the terms of the amended Fourth Section of the Interstate Commerce Act is permitted by authority of the Federal Energy Regulatory Commission, Fourth Section application dated November 27, 2019, as indicated herein.

The provisions published herein will, if effective, not result in an effect on the quality of the human environment.

Deliveries to the Blue Knight terminal, the Rose Rock terminal, the Enterprise terminal, the Enbridge terminal, the Plains All-American terminal, the Magellan Terminal and the NGL Terminal will be assessed an additional pump over fee amounting to [U]\$0.08. Deliveries to Seaway will be assessed an additional pump over fee amounting to [U]\$0.10 per barrel.
- (4) Shipper may nominate barrels from the Pawnee and Buckingham Origins as a Flex Shipper at this rate. Shipper may nominate volumes for final delivery to the Various Cushing Destinations for an additional [U]\$0.25 per barrel fee, as well as, (1)

an [U]\$0.08 pump over fee for deliveries to the Blue Knight terminal, the Rose Rock terminal, the Enterprise terminal, the Enbridge terminal, the Plains All-American terminal, the NGL Terminal, and the Magellan Terminal, or (2) a [U]\$0.10 per barrel fee for deliveries to Seaway.

(8) In addition to the primary destination of Sterling ("Primary Destination"), shippers who executed a production dedication agreement may make deliveries to the Pawnee, Colorado or Buckingham, Colorado destinations ("Secondary Destinations"). All movements, whether to Primary Destination or Secondary Destinations, shall be charged the production dedication volume rate from the origin to the Primary Destination. Any barrels above Shipper's Production Dedication Volume shall receive a [U]\$0.15 discount off the then applicable production dedication volume rate.

(9) In addition to the primary destination of Sterling ("Primary Destination"), shippers who executed a committed shipper service agreement may make deliveries to the Pawnee, Colorado or Buckingham, Colorado destinations ("Secondary Destinations"). All movements, whether to Primary Destination or Secondary Destinations, shall be charged the committed shipper rate from the origin to the Primary Destination. Barrels above a shipper's minimum volume commitment shall be at the Incremental Committed Shipper Rate.

(10) As part of this volume incentive program, shippers may satisfy their obligations by shipping from Guernsey, Wyoming, Platteville, Colorado, and Buckingham, Colorado (collectively the "Origins") to the destination referred to as Various Cushing Destinations ("the Destination"). The Incentive Rate payable by a shipper on its minimum volume commitment and any incremental barrels will be the then-applicable Incentive Rate for shipments from the Origins to the Destination. In lieu of the PLA rates set forth above, a PLA of 0.2% shall be retained by Carrier. The following pump-over charges shall apply: (i) shipments to Seaway at the Various Cushing Destinations will be assessed an additional pump over fee of [U]\$0.10 per barrel; and (ii) shipments to the NGL Terminal and the Magellan Terminal at Cushing will be assessed an additional pump over fee of [U]\$0.08 per barrel.

(11) In addition to the primary destination of Sterling ("Primary Destination"), shippers who executed a transportation service agreement may make deliveries to downstream destinations in Kansas and Oklahoma ("Secondary Destinations"),

subject to the capability of such Secondary Destination. If a shipper elects to ship to a Secondary Destination, those barrels may also count toward any MVC obligations the shipper may have on the Main Line (as defined in the Rules and Regulations Tariff). If a shipper ships to a Secondary Destination, the shipper shall pay the committed rate set forth herein plus the applicable tariff rate and any associated pump-over charges for the Main Line transportation, but shall be charged the PLA fee from the origin to the Secondary Destination and not the sum of the PLA fees on the primary path (Guernsey to Sterling) and the Main Line.

(12) The Augusta Blend Incentive Rate shall apply to Petroleum with a viscosity greater than thirty (30) centistokes. The Light Incentive Rate shall apply to Petroleum with a viscosity of thirty (30) centistokes or less. In connection with an assignment of a shipper's contractual obligation under this program, the assigning shipper may transfer shipping history in the applicable pipeline segments to the assignee in an amount not to exceed the minimum volume commitment being assigned.

(15) Shippers participating in this program must have a production dedication from both Buckingham, CO and from Pawnee, CO. In addition to the primary destination of Cushing, OK ("Primary Destination"), shippers who executed a dedication transportation service agreement may make deliveries, subject to available capacity, to intermediate destinations in Kansas and Oklahoma that are upstream of Cushing, OK ("Secondary Destinations"). All movements, whether to the Primary Destination or Secondary Destinations, shall be charged the incentive rate from the applicable origin, i.e., Buckingham or Pawnee, to the Primary Destination, except as provided in footnote 2. A shipper may ship up to ten thousand (10,000) BPD of petroleum in excess of its Buckingham dedication ("Buckingham First Tier Extra Barrels") at the Buckingham committed rate. Any barrels in excess of the Buckingham First Tier Extra Barrels may be shipped at the extra barrel rate. A shipper may ship barrels of petroleum in excess of its Pawnee Dedication at the Pawnee committed rate.

(16) As part of this volume incentive program, Shippers may satisfy their obligations by shipping from the Primary Origin (Sterling, Colorado) or upstream origins (except for Platteville, Colorado) to the Destination (Various Cushing Destinations) or to the intermediate destinations in Kansas and Oklahoma that are upstream of Cushing, OK. The Incentive Rates payable by a Shipper on its minimum volume commitment and any extra barrels from the Primary Origin will be the then-applicable Incentive Rates for shipments from the Primary Origin to the Destination, regardless of whether the Shipper ships to that Destination or to an alternative destination, except as provided

in footnote 2. If Shipper ships from an upstream origin (other than Platteville, Colorado), the Shipper shall be charged the applicable rate from the upstream origin to Sterling, Colorado plus the Incentive Rate. The applicable Incentive Rate or Secondary Origin Barrel Rate shall be determined based on the Rate Incentive Shipper's total Minimum Volume Commitment, not the amount shipped by the Rate Incentive Shipper in a given Month.

The Incentive Rates and Secondary Origin Barrel Rates may be indexed annually to reflect the inflation adjustments promulgated annually by FERC; provided however, Carrier shall not be required to reduce any of the then-current rates to reflect application of a negative indexing adjustment. In connection with an assignment of a Shipper's contractual obligation under this program, the assigning Shipper may transfer shipping history in the applicable pipeline segments to the assignee in an amount not to exceed the minimum volume commitment being assigned.

If Shipper ships from the Primary Origin, Shipper shall be charged the PLA percentage set forth in the PLA tables herein applicable to the movement. If Shipper ships from an upstream origin other than Platteville, Colorado, the Shipper shall be charged the PLA percentage set forth in the PLA tables herein applicable to a movement from the upstream origin to the destination not the sum of the product loss allowance fees; provided however, the product loss allowance for shipments from the Platteville, Colorado Origin shall be 0.20%.

(17) The Shipper A Incentive Rates and Extra Barrel Rates are available to each shipper that, as a result of the March 7, 2025 open season, obtained a fully executed Volume Commitment and Rate Incentive Agreement ("RIA") and elected to become a Rate Incentive Shipper A. The Shipper B Incentive Rates and Extra Barrel Rates are available to each shipper that elected to become a Rate Incentive Shipper B pursuant to an RIA. The applicable Incentive Rate Tier shall be determined based on the Shipper's total minimum volume commitment, not the amount shipped by such Shipper in a given month. The Secondary Origin Barrel Rates and the Buckingham Barrel Rate are available to a Rate Incentive Shipper A and a Rate Incentive Shipper B.

In addition to the primary destination of Cushing, OK ("Primary Destination"), Shippers who executed an RIA may make deliveries, subject to available capacity, to intermediate destinations in Kansas and Oklahoma that are upstream of Cushing, OK ("Secondary Destinations"). All movements from Platteville, CO, whether to the Primary Destination or Secondary Destinations, shall be charged the Incentive Rate or Extra Barrel Rate, as applicable, from the Platteville, CO origin ("Primary Origin") to the Primary Destination, except as provided in footnote 2. The first nine thousand (9,000) BPD above a Shipper's minimum volume commitment shall be at the applicable Incentive Rate, any barrels above that shall be at the Extra Barrel Rate.

Shippers may fulfill up to 5,000 BPD of their MVC by shipping from the Buckingham Origin.

A Shipper may also ship barrels from Guernsey, WY or Sterling, CO (“Secondary Origins”) to the Primary or Secondary Destinations at the Secondary Origin Barrel Rate, but such volumes do not count towards the Shipper’s minimum volume commitment. The applicable Secondary Origin Barrel Rate Tier in a given Month shall be determined based on Shipper’s aggregated Shipments of Secondary Origin Barrels in such Month from either Guernsey, WY or Sterling, CO. All Secondary Origin Barrel Shipments will be charged the rate for which Shipper qualifies in a given Month, e.g., if Shipper qualifies for the Tier II Rate in a given Month, all of Shipper’s Secondary Origin Barrels for such Month will be assessed the Tier II Rate. Secondary Origin Credited Barrels will always be subject to the Tier I Secondary Origin Barrel Rate.

The applicable product loss allowance for all movements from the Primary Origin or the Buckingham Origin shall be 0.20%. The applicable product loss allowance for all movements from a Secondary Origin shall be 0.15%. In connection with an assignment of a Rate Incentive Shipper’s contractual obligation under this program, the assigning Rate Incentive Shipper may transfer shipping history in the applicable pipeline segments to the assignee in an amount not to exceed the minimum volume commitment being assigned.
