The Pipeline Loss Allowance (“PLA”) for all tariff movements and line fill return will be based on the PLA chart above.

(1) Includes the Blue Knight terminal, the Rose Rock terminal, the Enterprise terminal, the Enbridge terminal, the Plains All-American terminal, the Deeprock South terminal, the NGL Energy Partners terminal (“NGL”), the Seaway Crude Pipeline Company LLC (“Seaway”) and the Deeprock North Terminal. Deliveries to NGL and to Seaway will be assessed additional pump over fees amounting to [U]\$0.08 per barrel for deliveries to NGL and [U]\$0.10 per barrel for deliveries to Seaway.

(2) All movements to the Augusta Destination or the McPherson Destination shall be subject to an additional fee (i.e., in addition to all other applicable tariff rates, fees, and charges) of [U]\$0.10 per barrel.

(3) Deliveries to Deeprock South terminal and Deeprock North terminal are included. Deliveries to the Blue Knight terminal, the Rose Rock terminal, the Enterprise terminal, the Enbridge terminal, the Plains All-American terminal, and the NGL will be assessed an additional pump over fee amounting to [U]\$0.08. Deliveries to Seaway will be assessed an additional pump over fee amounting to [U]\$0.10 per barrel.

(4) Shipper may nominate barrels from the Pawnee and Buckingham Origins as a Flex Shipper at this rate. Shipper may nominate volumes for final delivery to the Various Cushing Destinations for an additional \$0.25 per barrel fee, as well as, (1) an \$0.08 pump over fee for deliveries to the Blue Knight terminal, the Rose Rock terminal, the Enterprise terminal, the Enbridge terminal, the Plains All-American terminal, the NGL, or (2) a \$0.10 per barrel fee for deliveries to Seaway.

(5) [N]As part of this volume incentive program, shippers may satisfy their obligations by shipping from the Origin (Sterling, Colorado) or upstream origins to the Destination (Various Cushing Destinations) or any other destinations on the pipeline. The Volume Incentive Rates payable by a shipper on its minimum volume commitment and any extra barrels will be the then-applicable Volume Incentive Rates for shipments from the Origin to the Destination regardless of whether the shipper ships to that Destination or to an alternative destination; except as provided in footnote 2. If shipper ships from an upstream origin, the shipper shall be charged the Uncommitted Rate from the upstream origin to Sterling, Colorado plus the applicable Volume Incentive Rate.

The applicable Volume Incentive Rates shall be determined based on shipper’s total shipments in the month. If shipper ships more barrels in a month than the volume tier associated with shipper’s minimum volume commitment, then all barrels shipped by shipper in such month shall be charged the Volume Incentive Rate applicable to the volume and rate tier one tier above shipper’s volume tier. Regardless of the number of

barrels shipped in the month, shipper will not qualify for a Volume Incentive Rate more than one tier above shipper’s volume tier.
