Re: Rockies Express Pipeline LLC Annual Penalty Charge Reconciliation Filing Docket No. RP24-_____-000

Dear Acting Secretary Reese:

Pursuant to Section 37 ("Crediting of Penalty Charges") of the General Terms and Conditions of its FERC Gas Tariff, Third Revised Volume No. 1 ("Tariff"), Rockies Express Pipeline LLC ("Rockies Express") hereby submits this reconciliation filing pertaining to the penalty charges collected during the period from January 1, 2023 through December 31, 2023 ("Current Reporting Period").

Tariff Requirements

In accordance with Section 37.1.B of the Tariff, for each reporting period, Rockies Express must compare penalty charges and related costs, and determine if the penalty charges were in excess of costs (*i.e.*, net penalty charge revenues) or if costs were in excess of penalty charges (*i.e.*, net penalty charge costs). Pursuant to Section 37.1.C, net penalty charge revenues, if any, shall be refunded through a direct payment or invoice credit. The refund of the net penalty charge revenues is to be allocated to each shipper based on the ratio of actual revenues for each shipper to the total revenues collected by Rockies Express during the reporting period, net of any applicable surcharges. Section 37.1.D provides that any net penalty charge costs, if applicable, shall be rolled forward into succeeding reporting periods until eliminated.

Penalty Charge Refunds

Rockies Express has determined that it collected \$11,447.57 in penalty charge revenues related to cashouts during the reporting period. The attached Appendix A reflects the penalty charge revenues from the Current Reporting Period. Appendix B details the allocation of the total Penalty Charge revenues of \$11,447.57 to individual shippers. Applicable credits will post to shipper invoices issued in June 2024 for business during the month of May 2024.

Motions and Waivers

Rockies Express requests that the Commission grant any waivers of its regulations as it may deem necessary for acceptance of this penalty charge reconciliation filing.
