Pursuant to the Purchase and Sale of Gas provisions in Section 11.6 of the General Terms and Conditions ("GT&C") of Third Revised Volume No. 1 of the Rockies Express Pipeline LLC ("Rockies Express") FERC Gas Tariff ("Tariff") and Section 154.502(c) of the regulations of the Federal Energy Regulatory Commission ("Commission"), Rockies Express hereby submits for filing its annual report on incidental operational gas purchase and sale transactions for the calendar year ending December 31, 2024 ("Report"). Rockies Express is filing this Report pursuant to the Commission's eFiling procedures.

## **Background**

Pursuant to GT&C Section 11.6 of the Tariff, Rockies Express must submit an annual report that provides details regarding all incidental operational gas purchases and sales made during the previous calendar year. The Tariff requires Rockies Express to include in this report the counterparty, the date of the purchase/sale, quantity, and the purchase/sale price for each operational gas purchase/sale transaction. The Tariff also requires that the annual report provide information on: (1) the cost and revenue associated with the purchase/sale; (2) identification of the source of the gas; (3) an explanation as to the purpose of the purchase/sale; and (4) all entities, including affiliates, from which Rockies Express purchased operational gas.
