The Pipeline Loss Allowance ("PLA") for all tariff movements (whether contract or non-contract) will be based on the PLA charts above. Shippers shall also pay a pipeline loss allowance associated with the Deeprock terminal based on actual loss experienced at the Deeprock terminal.

(1) Deliveries to the following Cushing destinations: Blue Knight terminal, Rose Rock terminal, Enterprise terminal, Enbridge terminal, Plains All-American terminal, Deeprock South terminal, Deeprock North terminal, and NGL Energy Partners terminal will be assessed additional pump over fees of [U]\$0.08 per barrel. Deliveries to the Seaway Crude Pipeline Company LLC will be assessed an additional pump over fee of [U]\$0.10 per barrel.

The committed shipper rates are available to those shippers that entered into a joint Throughput and Deficiency Agreement ("Joint TDA") with Carrier and Bridger Pipeline LLC, Belle Fourche Pipeline Company, and Butte Pipe Line Company (collectively the "Trues") during the open season carriers held commencing March 4, 2021, and committed therein to ship on a primary basis from an origin on the Trues (the "Primary Origin") to a destination on Carrier in Cushing, Oklahoma ("Joint Committed Shippers"). The Joint TDA gives Joint Committed Shippers the right to ship from local origins on Carrier on a secondary basis ("Secondary Origins") at the committed shipper rate applicable to the joint movement, i.e., the movement from the Primary Origin to Cushing, Oklahoma. Joint Committed Shippers may also ship barrels from the Secondary Origins that are in excess of their minimum volume commitment at the Extra Barrel Rate. The rates shown above are initial rates for Joint Committed Shippers only and are subject to adjustment pursuant to the Joint TDA. In addition to the rates shown above, the following additional fees will be charged: Joint Committed Shippers with a Cushing at Seaway Crude Pipeline Company LLC system destination shall pay a [U]\$0.02 per barrel pump-over fee. A Joint Committed Shipper with a destination in Cushing, Oklahoma may, on a space available basis, deliver to a different destination in Cushing or to the Ponca City destination at no extra charge; provided however, a Joint Committed Shipper using the Seaway Crude Pipeline Company LLC system destination, on a space available basis, shall incur a [U]\$0.02 per barrel pump-over fee. A Joint Committed Shipper may, on a space available basis, deliver to the Augusta or McPherson destinations, subject to a [U]\$0.10 per barrel pump-over fee.
