JOB TITLE	JOB DESCRIPTION
ACCOUNT DIRECTOR	Responsible for the maintenance of the existing business on the interstate pipeline assets which includes contract renewals and customer support. Markets Tallgrass to both present and potential customers. Directs account management activities for all aspects of customer business. Negotiates and prepares agreements for the transportation and storage of natural gas. Develops an effective working relationship with Tallgrass management and the management of connecting carriers.
ACCOUNT MANAGER	Analyzes U.S. supply/demand fundamentals, pricing and market trends and the potential market opportunity for a variety of commercial functions.
ADMINISTRATIVE ASSISTANT (CONTRACT ADMINISTRATION)	Point of contact for contract transactions with internal and external customers in addition to providing support services to the Business Management work group, which is responsible for customer service on the Tallgrass interstate assets.
ANALYST-BUSINESS PROCESS	For an interstate pipeline, provide a variety of analytical services that support and promote the Business Management and Development Department, including but not limited to analysis in the following areas: Systems/IT (user standpoint), Invoicing, Regulatory and Financial (budgets/forecasts). Responsible for formulating and defining systems scope and objectives through research and fact-finding combined with an understanding of applicable business systems and industry requirements under general supervision. Develops or modifies moderately complex information systems. Guides and advises less-experienced Business Systems Analysts. Analyzes business processes, identifies process deficiencies, researches solutions and plans and coordinates the remediation of these deficiencies. Assist with the design and implementation of operational and system enhancements to ensure production capabilities are both effective and efficient. As appropriate, write and validate business requirements and conduct system tests.
ANALYST-SCHEDULING	Provides quantitative and quality assurance support for the scheduling team.
ASSOCIATE CONTRACT ADMINISTRATOR	To act as a key point of contact for contract transactions with internal and external customers on all Tallgrass interstate natural gas pipeline facilities. The Associate Contract Administrator position is a junior role to the Contract Administrator position.
CONTRACT ADMINISTRATOR	To act as the key point of contact for contract transactions with internal and external customers on all Tallgrass interstate natural gas pipeline facilities. Coordinates the maintenance and updating of records pertaining to the sale and purchase of natural gas for system operations. Assists customers with capacity release program in accordance with the tariff requirements and industry standard deadlines. May provide guidance and training to Associate Contract Administrator. Usually has five or more years of experience.
CONTRACT ADMINISTRATOR SR	The key point of contact for contract transactions with internal and external customers on all Tallgrass interstate natural gas pipeline facilities. Acts as a first-line resource for the Contract Administrators and Associate Contract Administrators. Assists customers with capacity release program in accordance with the tariff requirements and industry standard deadlines. Coordinates gap identification, requirement documentation and testing of proprietary computer system. Usually has seven plus years of industry and contract administration experience.

DIRECTOR-ACCOUNT SERVICES	Manages key accounts for the Rockies Express Pipeline (REX), including establishing a network within the region, developing focus account client relationships, developing tenders and proposals and managing numerous stakeholders to ensure quality business development. Develops, negotiates, and administers transportation related agreements and strategies for the pipeline company to ensure customer satisfaction, loyalty, market growth and segmentation and value-added strategy initiatives. Ensures customer services and satisfaction through the development and implementation of innovative and quality marketing programs. Oversees the development and evaluation of transportation marketing opportunities and discounting strategies. Plans and directs the commercial marketing functions of an assigned area, including the development, negotiation, administration, and control of transportation and storage agreements. Directs and participates in strategic planning for transportation and storage agreements to meet existing and future delivery requirements. Builds and maintains close working relationships with customers.
DIRECTOR-COMMERCIAL ORIGINATION	The Director-Commercial Origination, with a focus on the Rockies Express Pipeline (REX), is expected to bring new transportation business in the Colorado, Nebraska, Kansas and Missouri area to the Rockies Express Pipeline. Primarily responsible for marketing the commercial gas supply needs for the Tallgrass interstate pipelines, with a focus on REX.
DIRECTOR-CONTRACT ADMINISTRATION & CUSTOMER SUPPORT	Responsible for directing the day-to-day contract administration functions and ensuring that all contracts are properly maintained. Acts as the point of contact to coordinate contract negotiations between company and the customer/supplier and provides the leadership and guidance necessary to strengthen the contract process and administration.
DIRECTOR-MARKETING	Responsible for marketing and managing the commercial storage services and gas supply needs for the Tallgrass Interstate Gas Transmission and Trailblazer Pipelines

FINANCIAL ANALYST SR. The Sr. Financial Analyst will act as a first-line resource for Financial Analysts and Associate Financial Analysts.
GAS CONTROLLER (all levels)	Dispatches, monitors and controls multiple interstate pipeline systems via SCADA to ensure their safe, reliable, and efficient operation consistent with business objectives and the governing tariffs.
GENERAL MANAGER & VP-TIGT/TRAILBLAZER	Responsible for business and financial operation of the Tallgrass Interstate Gas Transmission Pipeline and the Trailblazer Pipeline at an Executive level. Expected to play a significant company-level Executive leadership role relative to developing the Company's fundamental business strategy.
LEAD CONTROLLER	Coordinates the maintenance activity on multiple interstate pipelines while assisting management in day-to-day responsibilities to ensure the pipelines' safe, reliable, and efficient operation consistent with business objectives and the governing tariffs.
